COUNT ONE

The District Attorney of the County of Santa Clara, State of California, hereby accuses BIEN TREIU DOAN of a FELONY, to wit: a violation of CALIFORNIA PENAL CODE SECTION 475a (POSSESSION OF COMPLETED CHECK), in that on or about the 17th day of July, 1986, in the County of Santa Clara, State of California, the said defendant(s) did have in his possession a completed CHECK, with the intention to utter and pass the same and to permit, cause and procure the same to be uttered and passed, to defraud another person.

COUNT TWO

The District Attorney of the County of Santa Clara, State of California, hereby accuses BIEN TREIU DOAN of a FELONY, to wit: a violation of CALIFORNIA PENAL CODE SECTION 470 (FORGERY), in that on or about the 17th day of July, 1986, in the County of Santa Clara, State of California, the said defendant(s) with the intent to defraud, did sign the name of another person on a check for the payment of \$415.31, drawn on WELLS FARGO BANK, knowing he had no authority so to do, did falsely make, alter, forge and counterfeit said check, and did utter, publish, pass and attempt to pass as true and genuine said check, knowing it to be false, altered, forged and counterfeited.

COUNT THREE

Dismissed
